I, the undersigned, as group representative, hereby release, remise and forever discharge the Baileys Harbor Community Association, its officers and directors, severally or jointly, the Baileys Harbor Event Committee and the Town of Baileys Harbor, County of Door, State of Wisconsin, of any and all liability, claims, actions and possible causes of actions which may occur to any member of the group from every and any loss, damage and injury (including death) that may be sustained while participating in the parade.

I/we assume all risk of bodily injury or property damage that I/we may incur in participating in the Baileys Harbor 4th of July Festival Parade and I/we hereby, for myself, my child, my heirs, executors, and administrators do hereby expressly and forever waive and release any and all claims against and agree to hold the Baileys Harbor Community Association, its officers and directors, severally or jointly, the Baileys Harbor Event Committee and the Town of Baileys Harbor, County of Door, State of Wisconsin, and all their respective officers, employees, agents, representatives, successors, or assigns of any kind from any claim which may be made for any cause whatsoever arising as a result or in connection with the participation of me or my child in the herein mentioned event.

OFFICIAL RULES & PROCEDURES

1. All applications must be completed. Incomplete applications will be returned.
2. The Festival Parade Committee reserves the right to bar or remove from the parade any entry which refuses to follow all instructions from the Parade Officials or Police Officers.
3. The number of vehicles or persons with each unit must be specified in the application and be approved by the committee. Only that number will be allowed to participate.
4. The signed Waiver of Liability and Hold Harmless Agreement must accompany application.
5. Nothing may be thrown along the line of march per Door County Sheriff's Department.
6. Horse entries are required to provide sanitation crews following unit or have diapers on horses.
7. Consumption or possession of alcoholic beverages or illegal substances is forbidden on all entries & participants.
8. To ensure the quality of the parade, please be mindful of gaps between units.
9. Any entry which does not comply with all rules may jeopardize future appearances.
10. Please remember that this parade is designed to entertain families, especially children; it is not a commercial endeavor. All floats are encouraged to display their name or sponsor on the float but not be the focus of the float. Any entrant that wishes to use the parade as an advertising venue only and not decorating their vehicle/float according to the theme or spirit of the day will be charged \$25.
11. All entrants are responsible for the supplies necessary for the set-up and tear down of their unit.
12. All entrants are responsible for walking/inspecting the route before the parade to make sure their unit can clear any wires, trees, street lights, corners/turns, etc.
13. Absolutely no selling of concessions or other items along the parade route, before, during or after the parade.

HELPFUL HINTS FOR ENTRIES

- A float can consist of a low flatbed trailer (farm type), boat trailer (heavy duty), mobile home frame or other suitable frame with pneumatic-tired wheels.
- Self-propelled units integral to the float design are acceptable.
- The following recommended measurements are approximate Minimum/Maximum:
 - Length: 12'/60'
 - Width: 7'/12'
 - Height: Under 14'
 - Flatbed Clearance: 2'/4'
 - Skirting Clearance: 1"/2"
- Safety Measures:
 - Hand holds or other support for personnel standing on the float.
 - Float materials and costumes made from flameproof materials.
 - A fire extinguisher aboard the float or propulsion unit
 - Safety type couplers for all towing connections
 - Carefully secured lug nuts on all wheels

PARADE ROUTE NORTH TO SOUTH ON HWY 57

Floats are asked to take Hwy 57 S from the intersection at Ahrens Rd. The Highway will close at 9am and staging will be starting at Cty Q. All walking groups can drop off at the intersection of Cty Q and Hwy 57. Traffic will need to return to Ahrens Rd and park at Rec Park.

Parade will begin north of Ridges Rd and run directly to Summit Rd.

All floats requiring buses for walkers can destage at the intersection of Hwy 57 & Frogtown Rd or Summit Rd.

All floats & vehicles need to destage at Rec Park.
